**Rate Excludes:**

1. Rental Deposit R2000.00 (Cash or Credit card only) – (Payable upfront to the car hire company. **NOT to Gage**).
  - **If a company credit card is used the person's name on the credit card must be there to sign for the hired vehicle.**
  - This is refundable at the end provided that the hired vehicle is full of fuel, if not they will top it up and take it off the deposit.
  - They will also take a R95.00 Administration Fee
  - If any E-Toll highways were used will also be taken off before they refund the difference back
2. No Delivery or Collection fee with in 25km radius from the branch between 09:00- 16:00.
  - Any fuel from the branch to the client on Delivery will be for the client's account same applies with collection of the vehicle.
3. There will be a One-Way Fee of R1 500.00 applicable if you return the vehicle outside 150 km from the collection location.
4. On return of the hired vehicle if the vehicle is dirty inside (Mud, Dog hair etc.) a valet charge will be billed to the client.
5. Speeding: Excessive speeding fee R1500.00. Vehicle recovery fee R4000.00

**Please also see the two Excess Structures that apply when you take the hired car:**

1. Under the Standard excess option, the following would apply:

In the event of an accident, accidental damage, theft, hijacking, glass, tyre, hail damage, or any other damages, your excess would be R3 750.

Claim Handling fee of R825.00 per claim.
2. Excess waiver option

This option offers an **Excess Waiver** at an additional charge of R40.00 per day which would waive all the above-mentioned.

Should you choose to accept this option you will not be held liable for any excesses?

They would need to get payment upfront for the rental.

They would need credit card details to swipe for the rental period of the vehicles (Daily rate X the days booked for)
